TERMS AND CONDITIONS OF MONTHLY MEMBERSHIP AGREEMENT
Effective Jan 1, 2015

- Auto-renew can be cancelled at any time by contacting Breathe Yoga & Wellness at info@breatheyogawellness.com, however membership will be good through the end of that term.
- First month payment is required for sign up and will not be refunded under any circumstances.
- Membership commences on the date of sign up unless otherwise noted.
- All paid monthly memberships are not refundable in part or full after auto-draft has gone-through under any circumstances.
- Memberships paid upfront are not refundable in part or in full under any circumstances.
- A credit/debit card must be used for the first month's payment and registration fee.
- Memberships can not be set up without credit card information.
- Breathe Yoga & Wellness is in no way, under any circumstances, responsible or obligated to pay for member's bank penalties and/or over the limit fees.
- All paid monthly memberships will renew automatically within one month of membership unless member requests membership cancelation.
- For cancellations, holds, and/or changes to memberships for any reason, member must notify Breathe Yoga & Wellness via email at info@breatheyogawellness.com at least 10 days prior to next auto draft , putting "membership cancellation" as subject heading of email.
- In turn, Breathe Yoga & Wellness will send a confirmation via email after the changes have been made to the account. Member agrees that Breathe Yoga & Wellness could take up to 5 business days to respond.
- Once member has submitted an e-mail request for any changes to membership, it is member's responsibility to ensure that Breathe Yoga & Wellness has responded back on the same e-mail account to confirm processing the request.
- Breathe Yoga & Wellness is in no way, under any circumstances, responsible for member's negligence in checking their own bank statements to ensure that membership changes, holds, and/or cancellations have been processed correctly. In the event of miscommunication member is responsible to produce a copy of their request and response from Breathe Yoga & Wellness for review.
